Furthermore, it guarantees real-time tracking of your business, for example, in warehouse and production-related workflows. Each field and functionality is configurable inside NAV, so you can adopt custom modules and even specialized vertical solutions. Simply said, MobileNAV is a new user-interface for Dynamics NAV, optimized for smartphones and tablets. You can access your real-time data and functionality similarly to desktop clients. Offline capability allows to continue your work even without active network connection.

3. General Data Protection Regulation (GDPR)

The General Data Protection Regulation (GDPR) has comes into force in May 2018 and represents a significant overhaul of data protection legislation; the accountability principle will mean that businesses will need to examine how they hold and use data and take steps to demonstrate compliance with the data protection principles.

As businesses hold huge amounts of personal data relating to Customers, Vendors and Employees within their Dynamics NAV systems, currently there is very little functionality in existing or older versions (pre-NAV 2018) to support the new legislation.

4. Make Tax Digital (MTD)

Dynamics Nav is published by Microsoft Corp. and each publication includes country specific versions, and in the UK we have a GB version. The VAT MTD is specific only to the UK. Microsoft UK are responsible for liaising with HMRC to ensure all supported versions of Dynamics Nav will be VAT MTD compliant, such as:

- Dynamics NAV BC
- Dynamics NAV 2018
- Dynamics NAV 2017
- Dynamics NAV 2016

compliant with MTD.

Dynamics NAV 2015

All other versions prior to Dynamics NAV 2015 such as NAV 2009 not supported by Microsoft, then Customers are liable to take action to make it

The expectation is that this will involve development to allow the transmission of VAT returns directly to HMRC VAT databases. That said, it is important for companies to be on a supported version to receive any legislative updates as part of your enhancement plan.
